- ❖ Public List of Voters with a Ballot (CE-068) for the primary, general, and odd-year elections - daily after ballots are mailed (every four hours 1:15AM until 9:15PM)
- ❖ Public List of Voters with a Returned Ballot (CE-068c) for the primary, general, and odd-year elections - daily after ballots are mailed (every two hours 7:20AM until 9:20PM)
- ❖ Rejected Cure Ballots (CE-077) - daily after ballots are mailed
- ❖ Undeliverable Ballots (CE-037) - daily after ballots are mailed
