that in accordance with C.R.S. 12-47-801 (5)(c) (formerly 12-47-128.5), C.R.S. 13-21-102.5 (3)(c)(III), and C.R.S. 13-21-203.7(3), the adjusted limitations for damages, utilizing the “consumer price index for Denver-Boulder, all items, all urban consumers”, are as follows:

For all claims for relief that accrue on and after January 1, 1998, and before January 1, 2008:

FOR C.R.S. 12-47-801(3)(c) & 12-47-801(4)(c) the adjusted limitation is \$219,750.

FOR C.R.S. 13-21-102.5(3)(a) & 13-21-102.5(3)(b) the adjusted limitation is \$366,250 (which for C.R.S. 13-21-102.5(3)(a) may be increased by the court upon clear and convincing evidence to a maximum of \$732,500).

FOR C.R.S. 13-21-203(1) the adjusted limitation is \$341,250.

FOR C.R.S. 13-21-203.5 the adjusted solatium amount is \$68,250.

For all claims for relief that accrue on and after January 1, 2008, and before January 1, 2020:

FOR C.R.S. 12-47-801(3)(c) & 12-47-801(4)(c) the adjusted limitation is \$280,810.

FOR C.R.S. 13-21-102.5(3)(a) & 13-21-102.5(3)(b) the adjusted limitation is \$468,010 (which for C.R.S. 13-21-102.5(3)(a) may be increased by the court upon clear and convincing evidence to a maximum of \$936,030).

FOR C.R.S. 13-21-203(1) the adjusted limitation is \$436,070.

FOR C.R.S. 13-21-203.5 the adjusted solatium amount is \$87,210.

For all claims for relief that accrue on and after January 1, 2020, and before January 1, 2022:

FOR C.R.S. 12-47-801(3)(c) & 12-47-801(4)(c) the adjusted limitation is \$368,260.

FOR C.R.S. 13-21-102.5(3)(a) & 13-21-102.5(3)(b) the adjusted limitation is \$613,760 (which for 13-21-102.5(3)(a) may be increased by the court upon clear and convincing evidence to a maximum of \$1,227,530).

FOR C.R.S. 13-21-203(1) the adjusted limitation is \$571,870.

FOR C.R.S. 13-21-203.5 the adjusted solatium amount is \$114,370.

For all claims for relief that accrue on and after January 1, 2022, and before January 1, 2024:

FOR C.R.S. 12-47-801(3)(c) & 12-47-801(4)(c) the adjusted limitation is \$385,310.

FOR C.R.S. 13-21-102.5(3)(a) & 13-21-102.5(3)(b) the adjusted limitation is \$642,180 (which for 13-21-102.5(3)(a) may be increased by the court upon clear and convincing evidence to a maximum of \$1,284,370).

FOR C.R.S. 13-21-203(1) the adjusted limitation is \$598,350.

FOR C.R.S. 13-21-203.5 the adjusted solatium amount is \$119,660.

For all claims for relief that accrue on and after January 1, 2024, and before January 1, 2026:

FOR C.R.S. 12-47-801(3)(c) & 12-47-801(4)(c) the adjusted limitation is \$437,880.

FOR C.R.S. 13-21-102.5(3)(a) & 13-21-102.5(3)(b) the adjusted limitation is \$729,790 (which for 13-21-102.5(3)(a) may be increased by the court upon clear and convincing evidence to a maximum of \$1,459,600).

FOR C.R.S. 13-21-203(1) the adjusted limitation is \$679,990.

FOR C.R.S. 13-21-203.5 the adjusted solatium amount is \$135,990.
