Pursuant to C.R.S. § 24-4-103(11)(d)(II), the following corrections to the above-referenced rules are not substantive changes, but are corrections to typographical and grammatical errors.

212-1 – Medical Marijuana Rules:

Change the title of the rules to “Medical Marijuana Rules”  
M 103 – (a) adding a comma, a space and the word “of” between “circulation” and “visual” and (b) adding the word “communication” after “written” in the definition of “Advertising,” in order to create a complete sentence  
M 103 - Removing extra “in” from the definition of “flowering”  
M 404(B) and M 405(A) - Correcting statutory cross-reference  
M 1006(A)(2) - Removing random “B”

212-2 – Retail Marijuana Rules:

Change title of the rules to “Retail Marijuana Rules”  
R 103 – (a) adding a comma, a space and the word “of” between “circulation” and “visual” and (b) adding the word “communication” after “written” in the definition of “Advertising,” in order to create a complete sentence  
R 402(G), R 502(E), R 602(F), and R 902(B) and (C) - Remove outdated reference to 2013 excise tax election  
R 603 - Correct paragraph numbering to match M 603  
R 1006(B) - Correct reference to be 1006(A)(3) and not 1006(B)(3).
