Corrections to statutory citations for Life Care Institutions Regulations
3 CCR 703-2, Corrected Rules 4.1, 4.2, 5.1, 7.1, 8.1, 10.1, 11.1, 14.1.

Dear Mr. Williams:

The Office of Legislative Services has conducted an organizational review and has recommended recodification of certain provisions of Title 12, Colorado Revised Statutes, which relates to professions and occupations. The statute governing Life Care Institutions, which are regulated by the Division of Financial Services, was previously located at § 12-13-101 - 12-13-118, C.R.S. To implement the recommendation of the Office of Legislative Services, Senate Bill 17-226 relocated the Life Care Institutions statute to § 11-49-101 – 11-49-115, C.R.S. The Division of Financial Services regulations pertaining to Life Care Institutions were corrected to provide citations to the current location of the statute. No substantive changes were made to the regulations.

I have analyzed these corrections to the regulations, and based on my analysis, and in accordance with § 24-4-103(11)(l), C.R.S., I have found that:

(1) The general assembly has relocated the statute formerly located at §§ 12-13-101 – 12-13-118, C.R.S., in a manner that renders the citations to the statute in Rules Pertaining to Life Care Institutions inaccurate, and therefore the condition specified in § 24-4-103(11)(l), C.R.S. applies;

(2) The correct citation in the rules is to statutory provisions relocated to §§ 11-49-101 -- 11-49-115, C.R.S.; and

(3) The specific correct citations are as follows:

Rule 4.1 – Corrected references to §§ 11-49-102(1)(b) and 11-49-102(1)(b)(I)-(III), C.R.S., formerly §§ 12-13-104(1)(b) and 12-13-104(1)(b)(I)-(III), C.R.S.

Rule 4.2 – Corrected references to §§ 11-49-102(1) and (2), C.R.S., formerly §§ 12-13-104(1) and (2), C.R.S.

Rule 5.1 – Corrected references to § 11-49-103(2), C.R.S., formerly § 12-13-105(2), C.R.S.

Rule 7.1 – Corrected reference to § 11-49-105(2)(d), C.R.S., formerly § 12-13-107(2)(d), C.R.S.

Rule 8.1 – Corrected reference to § 11-49-106(3), C.R.S., formerly § 12-13-108(3), C.R.S.

Rule 10.1 – Corrected references to §§ 11-49-107, 11-49-106(1), C.R.S. and to Title 11, Article 49, formerly §§ 12-13-110, 12-13-108(1), C.R.S. and Title 12, Article 13.
