The Commissioner of the Colorado Department of Agriculture (“Department”) adopted changes to the Department’s rules “Administration and Enforcement of the Colorado Nursery Act” on February 22, 2018, effective April 15, 2018. The Attorney General’s rule opinion was electronically filed with your office on February 27, 2018, tracking number 2017-00598.

Within the rule attached to the agency’s request for the Attorney General’s rule opinion, a typographical error with regard to the introductory paragraph has been identified. Specifically, the following introductory paragraph was marked for deletion in the adopted rule and so should have been removed from the final rule filed with the Secretary of State:

Pursuant to the provisions and requirements of the Colorado Nursery Act to regulate the sale and distribution of nursery stock, and by authority of Title 35, Article 26, Section 111, C.R.S., the following rules, which apply to all nursery stock sold or offered for sale in this state, are hereby promulgated:

A copy of the corrected introduction to the rule has been filed with the agency’s request for this correction letter, tracking number 2018-00174.

This requested change is submitted to you for publishing in the Colorado Code of Regulations pursuant to § 24-4-103(11)(d)(II), C.R.S., of the State Administrative Procedure Act. The matter being corrected is a non-substantive typographical error.
