The Commissioner of the Colorado Department of Agriculture (“Department”) adopted changes to the Department’s rules “Bureau of Animal Protection Rules” on April 11, 2018, effective May 30, 2018. The Attorney General’s rule opinion was electronically filed with your office on April 16, 2018, tracking number 2018-00062.

A typographical error exists within the rule that the Department submitted with its request for the Attorney General’s rule opinion. Specifically, the following words, which were presented in the final rule proposed to the Commissioner after consideration at the rule-making hearing, did not make it into the text submitted for publication: “per authority provided by the Commissioner.”

Rule 5.1.4.4 should read, in its entirety: “Total number of summonses issued per authority provided by the Commissioner.”

The Department of Agriculture filed a request for correction letter with your office, tracking number 2018-00173.

This requested change is submitted to you for publishing in the Colorado Code of Regulations pursuant to § 24-4-103(11)(d)(II), C.R.S., of the State Administrative Procedure Act. The matter being corrected is a non-substantive typographical error.
