CCR 748-1
Letter for Correction of Statutory Citations, SOS Tracking No.2019-00382.

Dear Ms. Griswold:

Pursuant to section 24-4-103(11)(l)I(A), C.R.S., the Office of Speech-Language Pathology Certification requests corrections to the statutory citations in the above referenced rules. With the passage of HB19-1172, the General Assembly relocated the Speech-Language Pathology Practice Act, which has rendered the rules' citations to the statute inaccurate.

HB19-1172, and the organizational recodification of Title 12, relocated the Speech-Language Pathology Practice Act from Title 12, Article 43.7, to Title 12, Article 305. The non-substantive relocation requires that statutory references within the rules be changed to accurately reflect the recodified citations. The current rules still reference now-incorrect title 12 citations and the Director of the Division of Professions and Occupations ("Director") request corrections. First, the Director seeks to have the rules conform with the Secretary of State's Rules Styling Manual, by changing § to section, capitalizing Rule, changing Rule numbers and references thereto (e.g., from Rule 6 to Rule 1.6), renumbering certain subsections from romanette letters to numbers in parentheses, and by capitalizing the first word of subsections. Second, the Director seeks to make the following non-substantive changes to reflect the recodified citations:

24 to be changed to *twenty-four*.

I submit that section 24-4-103(11)(l)(II), C.R.S., applies to this non-substantive rule change, and request that, pursuant to section 24-4-103(11)(l)(II), C.R.S., the Secretary of State make the above changes in the Code of Colorado regulations.
