RE: Correction Request Tracking No. 2020-00144

Dear Secretary of State Griswold:

On March 16th, the Colorado State Board of Education (“SBE”) submitted SOS Tracking No. 20199-00729, Proposed Amendments to 1 CCR 301-92, Rules for the Administration of the Colorado Reading to Ensure Academic Development Act (READ Act). At the final rulemaking hearing on March 12, 2020, the board adopted the proposed rule.

It has come to the SBE’s attention that the amended rules contain a typographical error in Rule 13.01(C)(2) by omitting the (b) in subpart 13.01(C)(2)(b). The corrected rule should be as follows:

13.01(C)(2) A teacher is deemed to have successfully completed evidenced-based training in teaching reading if the LEP submits evidence that the teacher:

13.01(C)(2)(a) successfully completed a CDE-provided reading training designed to meet this training requirement and passed the end of course assessment of learning; or

13.01(C)(2)(b) passed a CDE-approved undergraduate or graduate reading course and passed the end of course assessment of learning; or

13.01(C)(2)(c) passed a CDE-approved district or BOCES reading course or a course appropriate for license renewal and passed the end of course assessment of learning; or

13.01(C)(2)(d) holds a state of Colorado endorsement as a Reading Teacher or Reading Specialist; or

13.01(C)(2)(e) successfully completed a training program included on the department’s advisory list of professional development programs created pursuant to C.R.S. § 22-7-1209(2)(c) and passed the end of course assessment of learning.

On March 20th, 2020, SBE requested an a correction letter request via SOS tracking number 2020-00144 to correct the error designated above. SBE has submitted a corrected version of the Rules.

This correction is technical and non-substantive in nature and is submitted to you for publishing in the C.C.R. pursuant to C.R.S. § 24-4-103(11)(d)(II) of the State Administrative Procedure Act.
