RE: Correction Request Tracking No. 2020-00221

Dear Secretary of State Griswold:

On November 13, 2019, the Colorado State Board of Education (“SBE”) submitted SOS Tracking No. 20199-00529, Proposed Amendments to 1 CCR 301-71, Rules for the Administration, Certification and Oversight of Colorado Online Programs.

It has come to the SBE’s attention that the amended rules contain two typographical errors. First, Rule 4.05 cross references “2.06” when it should be “2.05.” Next, Rule 6.01 restates § 22-30.7-109.5 but omits the statute’s reference to “online program.” The corrected rules should be as follows:

4.05 The Authorizer will include in its application a list of the Learning Centers for which an MOU has been agreed upon by the local school district and the Online School, including the name, address, facility contact, and telephone number for each, and evidence of compliance by the Learning Center with section §2.05 of these rules.

6.01 Pursuant to § 22-30.7-109.5, C.R.S., each Online School that is not a charter school and online program shall submit to its Authorizer an annual financial and accounting report, which the Authorizer shall submit to the Department on or before December 31st of each year, or up to sixty days later, if an extension is requested pursuant to § 29-1-606 (4), C.R.S. Said report shall be submitted in accordance with 1 CCR 301-39, Amended Rules for Administration of Public School Finance, in section 2254-R-7.00.

On April 9, 2020, SBE requested an a correction letter request via SOS tracking number 2020-00221 to correct the errors noted above. SBE has submitted a corrected version of the Rules.

This correction is technical and non-substantive in nature and is submitted to you for publishing in the C.C.R. pursuant to C.R.S. § 24-4-103(11)(d)(II) of the State Administrative Procedure Act.
