NOTICE OF PUBLIC RULE-MAKING HEARING BEFORE THE COLORADO BOARD OF HEALTH

NOTICE is hereby given pursuant to the provisions of Section 24-4-103, C.R.S., that the Colorado Board of Health will conduct a public rule-making hearing on **January 20, 2010** in the Sabin-Cleere Conference Room of the Colorado Department of Public Health and Environment, Bldg. A, First Floor, 4300 Cherry Creek Drive, South, Denver, CO 80246, to consider the promulgation of **amendments to 6 CCR 1009-1, Rules and Regulations Pertaining to Epidemic and Communicable Disease Control**. The Board meeting commences in the morning. The purpose of this hearing is to receive public comments on proposed amendments to 6 CCR 1009-1, Rules and Regulations Pertaining to Epidemic and Communicable Disease Control, Regulations 1, 3 and 11. The proposed changes include adding chlamydia (currently on the list of laboratory reportable conditions) to the list of diseases that require provider reporting within seven days (Regulation 1, List B) and clarifying hepatitis C laboratory reporting requirements (Regulation 3). The expansion of chlamydia surveillance will allow the Department to more adequately characterize and monitor the growing problem of these infections, and better target screening, prevention and education efforts. Clarifying the language for hepatitis C reporting will enhance surveillance and provide needed information in the initial report. In addition, the proposed amendments also include adding hepatitis C to the list of sexually transmitted infections (Regulation 11), as well as several technical changes to update the terminology in Regulation 11.

The proposed rules have been developed by the Disease Control and Environment Epidemiology Division of the Colorado Department of Public Health and Environment pursuant to Section 25-1-122, Section 25-4-401, and Section 25-4-402 C.R.S.

The Board encourages all interested persons to participate in the hearing by providing written data, views, or comments, or by making oral comments at the hearing. At the discretion of the Chair, oral testimony at the hearing may be limited to five minutes or less depending on the number of persons wishing to comment.

The Board requests submission of written materials at least seven days prior to the hearing date, to allow the Board sufficient time to review the comments prior to the meeting. Persons wishing to submit written comments or views should submit them to:
