- 4.1.1.3 Experience Record
- 4.1.1.7 Application for Licensure by Prior Practice
- 4.1.1.8 Application for Licensure by Endorsement
- 4.5.1(e) Educational Standards
- 4.5.2 (i) Practical Experience Standards

And to update and clarify language and terminology, general housekeeping (correcting typographical errors, formatting, capitalization, punctuation, etc.) for all rule sections.

A copy of the proposed rules and a statement of statutory authority, basis and purpose are attached. Please be advised that these rules may be changed after public comment and formal hearing. The rules will be effective January 1, 2012.

STATEMENT OF BASIS AND PURPOSE

The basis for the adoption of the following rules is: Section 12-45-107(1)(a) of the Colorado Revised Statutes.

The purpose for the adoption of these rules is:

- Correct rule 4.1.1.3 for experience requirements;
- Repeal rule 4.1.1.7 regarding licensure by prior practice which no longer applies;
- Correct rule 4.1.1.8 for licensure by endorsement;
- Repeal rule 4.5.1(e) regarding educational standards for prior practice applicants which no longer applies;
- Addition of rule 4.5.2(i) regarding experience;
- Update and clarify language and terminology, general housekeeping (correcting typographical errors, formatting, capitalization, punctuation, etc.) for all rule sections.
