## NOTICE OF PUBLIC RULE-MAKING HEARING BEFORE THE COLORADO BOARD OF HEALTH

NOTICE is hereby given pursuant to the provisions of Section 24-4-103, C.R.S., that the Colorado Board of Health will conduct a public rule-making hearing on September 19, 2012 at Pueblo City-County Health Department, 3<sup>rd</sup> Floor Conference room, 101 West 9<sup>th</sup> Street, Pueblo, CO. 81003 to consider the promulgation of amendments to 6 CCR 1015-8, rules pertaining to Service Grants for the Dental Assistance Program for Seniors. The Board meeting commences in the morning. The purpose of this hearing is to receive public comments on the proposed rule changes regarding eligibility of seniors to participate in this program, reinstating the provider reimbursement schedule for the Dental Assistance Program and changing grantee required documentation. The proposed rules (amendments) are based upon statute changes regarding the eligibility requirements of seniors, the need to reinstate the expired provider reimbursement schedule and increased program funding which may require more grantee applications.

The proposed rules have been developed by the Oral Health Unit, Prevention Services Division of the Colorado Department of Public Health and Environment pursuant to Section 25-21-107.5, C.R.S.

The Board encourages all interested persons to participate in the hearing by providing written data, views, or comments, or by making oral comments at the hearing. At the discretion of the Chair, oral testimony at the hearing may be limited to five minutes or less depending on the number of persons wishing to comment.
