NOTICE OF PUBLIC RULE-MAKING HEARING BEFORE THE COLORADO BOARD OF HEALTH

NOTICE is hereby given pursuant to the provisions of Section 24-4-103, C.R.S., that the Colorado Board of Health will conduct a public rule-making hearing on February 20, 2013 at 10 a.m. in the Sabin-Cleere Conference Room of the Colorado Department of Public Health and Environment, Bldg. A, First Floor, 4300 Cherry Creek Drive, South, Denver, CO 80246, to consider the promulgation of amendments to **6 CCR 1009-2, Rules Pertaining To The Infant Immunization Program, The Vaccines For Children Program, And The Immunization Of Students Attending School**. The purpose of this hearing is to receive public comments on proposed amendments that make several changes to Table 1, including updating implementation dates for the upcoming school year, updating dosage requirements for certain vaccinations, removing outdated references and clarifying footnotes to reflect recommendations by ACIP. The proposed amendments also remove references in Table 2 to Tdap implementation

The proposed rules have been developed by the Colorado Immunization Section of the Colorado Department of Public Health and Environment pursuant to Sections C.R.S. 25-4-904 and 25-4-1705 (5).

The Board encourages all interested persons to participate in the hearing by providing written data, views, or comments, or by making oral comments at the hearing. At the discretion of the Chair, oral testimony at the hearing may be limited to five minutes or less depending on the number of persons wishing to comment.

Written testimony must be submitted to the Board no later than five (5) calendar days prior to the rulemaking hearing.
