NOTICE OF PUBLIC RULE-MAKING HEARING BEFORE THE COLORADO BOARD OF HEALTH

NOTICE is hereby given pursuant to the provisions of Section 24-4-103, C.R.S., that the Colorado Board of Health will conduct a public rule-making hearing on March 20, 2013 at 10 a.m. in the Sabin-Cleere Conference Room of the Colorado Department of Public Health and Environment, Bldg. A, First Floor, 4300 Cherry Creek Drive, South, Denver, CO 80246, to consider the promulgation of amendments to **6 CCR 1015-8, rules pertaining to Service Grants for the Dental Assistance Program for Seniors**. The purpose of this hearing is to receive public comments on the proposed amendments regarding allowable procedures and reimbursement rates for dental services to the existing Rules for Service Grants for the Dental Assistance Program. The proposed rules (amendments) are based upon recommendations of the Dental Advisory Committee regarding allowable dental procedures and reimbursement rates in accordance with sections 25-21-107.5(2)(c) and 25-21-105(6), C.R.S., signed into law May 22, 2012.

The proposed rules have been developed by the Oral Health Unit, Prevention Services Division of the Colorado Department of Public Health and Environment pursuant to Section 25-21-107.5, C.R.S.

The Board encourages all interested persons to participate in the hearing by providing written data, views, or comments, or by making oral comments at the hearing. At the discretion of the Chair, oral testimony at the hearing may be limited to five minutes or less depending on the number of persons wishing to comment.

Pursuant to 6 CCR 1014-8.3.02.1, written testimony must be submitted to the Board no later than five (5) calendar days prior to the rulemaking hearing.
