 - Anticipated scope of testimony, i.e., the <u>specific proposed rules</u> on which the party or individual will testify
 - Requested <u>length</u> of testimony <u>for each proposed rule</u> on which the party or individual will testify
 - Whether the party or individual intends to present documentary, audio, or visual evidence at the hearing, including any audio/visual presentation requirements
