**CAMPAIGN AND POLITICAL FINANCE
2021 COUNTY ANNUAL / INFREQUENT FILING CALENDAR**

Federal/State holidays are denoted in red; in most cases the office is closed on these dates.

This calendar applies to (refer to Campaign Finance Rule 17):

- County Candidates and Candidate Committees whose office does NOT attempt access to or appear on the November 2, 2021 Coordinated / Biennial School Election ballot
- Junior College Board of Trustee Candidates (for Northwestern Community college) whose office does NOT attempt access to or appear on the November 2, 2021 Coordinated / Biennial School Election ballot
- County Issues Committees (IC) whose issue does NOT attempt access to or appear on the November 2, 2021 Coordinated / Biennial School Election ballot
- County Political Parties (PP)*
- County Political Committees (PC)*
- County Small Donor Committees (SDC)*
- County 527 Political Organizations (527 PO)*
- County Independent Expenditure Committees (IEC)*

* Any candidate, party or committee, except for Issues Committee, **participating in the November 2, 2021, Biennial School Election must file disclosure reports according to the 2021 Biennial School Election schedule.** You must notify Campaign Finance Support to update your filing schedule immediately upon participation in the Biennial School Election.

Notes:

- Small-Scale Issue Committees (SSIC) are not required to file disclosure reports until they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, SSICs are subject to the disclosure requirements of 1-45-108(2), C.R.S.

The following types of supplemental reports may be required dependent on activity:

- **Regular Biennial School Electioneering Communication** (if the communication mentions school board candidates) time period starts 60 days (September 3, 2021) before the Biennial School Election.
- **24 Hour Notice of Major Contributor (MC) report** period starts 30 days before the Biennial School Election and concludes the day before the election. Report is due within 24 hrs. of receiving a Major Contribution. Applies to candidate committees whose office appears on the Biennial School Board Election ballot. It also applies to Issue Committees and Political Parties even if they are not participating in the election.
- **48 Hour Notice of Independent Expenditure (IE) report** period starts 30 days before the election and concludes the day before the election. Report is due within 48 hours of spending. Only applies to IECs.

September

- 3 Starts the 60 day period before the Biennial School Board Election for Biennial School Electioneering Communication and concludes on November 1, 2021

October

- 3 Starts the 30 day period before the Biennial School Board Election for 24 Hour MC rpts. & 48 Hour IE rpts. and concludes on November 1, 2021

November

 - October 28, 2020 through October 27, 2021

 - November 29, 2020 through October 27, 2021
