- Electioneering Communication (EC) mentions candidates and are part of the regularly scheduled reports for registered committees. EC reports do not apply to Issue Committees.
- 24-Hour Major Contributor Reports do not apply to PCs, 527s and IECs.
- 48-Hour Independent Expenditure Reports only apply to IECs.
- Small-Scale Issue Committees (SSIC) file disclosure reports once they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, they are subject to the disclosure requirements of 1-45-108, C.R.S.

#### May

- Starts the 30-day period before the Primary election for 24-Hour Major 26 Contributor & 48-Hour Independent Expenditure reports and concludes on June 24, 2024
- 26 Starts the time period for Electioneering Communications and continues through November 4, 2024

#### June

- 21st Day before the Primary Election report covers:
  - October 28, 2023 through May 30, 2024

# OR

- December 8, 2023 through May 30, 2024
- 21 Friday before the Primary Election report covers May 31, 2024 through June 16, 2024
- 25 Primary Election

# July

35th Day after the Primary Election - report covers June 17, 2024 through July 25, 2024

## October

- Starts the 30-day period before the General Election for 24-Hour Major Contributor and 48-Hour Independent Expenditure reports and concludes on November 4, 2024
- 21st Day before the General Election report covers July 26, 2024 through October 10, 2024

## November

- Friday before the General Election report covers October 11, 2024 through October 27, 2024
- **General Election**

35th Day after the General Election - report covers October 28, 2024 through December 5, 2024
