



2025 Campaign and Political Finance **Municipal** Filing Calendars (Frequent and Infrequent) Election: November 4, 2025

If the municipal election **IS NOT** held on November 4, 2025, contact the municipal clerk for filing deadlines. Home Rule municipalities may have a different filing schedule; check with your municipal clerk to verify disclosure report due dates. All municipal campaign finance reports are filed with the municipal clerk’s office.

60 days before the Election	09-05-2025	10-28-2024 <i>or</i> 12-06-2024 through 08-31-2025
30 days before the Election	10-07-2025*	09-01-2025 through 09-30-2025
15 days before the Election	10-20-2025	10-01-2025 through 10-15-2025
30 days after the Election	12-04-2025	10-16-2025 through 11-29-2025

- Candidates and Candidate Committees whose candidate does NOT attempt access to or appear on the November 4, 2025, Election ballot.
- Issue Committees whose issue does NOT attempt access to or appear on the November 4, 2025, Election ballot.

1 st day of the month in which the anniversary of the major election occurs	11-3-2025*	10-28-2024 <i>or</i> 12-08-2024 through 10-27-2025

Additional Information:

- All municipal campaign finance reports are filed with the municipal/town clerk's office.
- **Small-Scale Issue Committees (SSIC)** are not required to file disclosure reports until they exceed \$5,000 in activity. For more details, please review 1-45-108(1.5) and (2) of the Colorado Revised Statute (C.R.S.).
- **Types of supplemental reports** are large dollar and time-sensitive reports that may be required depending on your activity (please contact your municipal clerk for additional details):

- **24-Hr. Notice of Major Contributor** report period starts 30 days (October 5, 2025) before the Biennial School Board Election and concludes the day before the election. Reports are due within 24 hours of receiving a Major Contribution. This applies to:
 - Candidate Committees whose candidate attempts access to or appears on the ballot, and
 - Issue Committees (whether they are or are not participating in the election).

Note: Political Parties are NOT required to file this report during odd-calendar years.

- **48-Hr. Notice of Independent Expenditure** report period starts 30-days before election and ends the day before each election. Independent Expenditures of \$1,000 or more, made during this time period requires you to file an additional report providing details of the Independent Expenditure(s). This applies only to Independent Expenditure Committees (IEC).
