- **Regular Biennial School Electioneering Communication** (if the communication mentions school board candidates) period starts 60 days (September 5, 2025) before the Biennial School Election and concludes the day before the election. If you are a registered committee, this will appear on your regular report.
- **24-Hour Notice of Major Contributor** report period starts 30 days (October 5, 2025) before the Biennial School Board Election and concludes the day before the election. Reports are due within 24 hours of receiving a Major Contribution. Applies to candidate committees whose office appears on the Biennial School Board Election ballot. Political parties are NOT required to file this report during the odd-calendar year.
- **48-Hour Notice of Independent Expenditure** report period starts 30 days (October 5, 2025) before the Biennial School Election and concludes the day before the election. Report is due within 48-hours of obligating funds and/or spending. Only applies to Independent Expenditure Committees.
