<p>ELECTIONS DIVISION'S MOTION FOR AN EXTENSION OF TIME</p>	

The Elections Division of the Colorado Secretary of State respectfully requests a 21-day extension of time to file Exceptions to the Initial Decision in this action, up to and including April 4, 2024. As good cause, the Division states:

1. The Initial Decision was issued in this matter on February 13, 2024. Under the Deputy Secretary’s Procedural Order, issued that same day, Exceptions to the Initial Decision are due 30 days from the date of the Procedural Order, or March 14, 2024.

2. The Division is in the process of obtaining a transcript of the hearing conducted in this matter, and requires additional time to receive the transcript and incorporate citations to the transcript into its Exceptions as appropriate.

3. Moreover, undersigned counsel was traveling out of the country the weeks of February 19 and February 26.

Accordingly, the Division respectfully requests a 21-day extension of time to file Exceptions to the Initial Decision in this matter, up to and including April 4, 2024.
