Pursuant to C.R.C.P. 41(a)(1)(A) and 8 CCR 1505-6, Rule 24.14.2, the Elections Division of the Secretary of State hereby provides notice of its voluntary dismissal, with prejudice, of its action against "Respondent" or the "Committee" Marie for D49 DD3.

1. Pursuant to C.R.C.P. 41(a)(1)(A), a plaintiff may dismiss an action "without order of court . . . by filing a notice of dismissal at any time before filing or service by the adverse party of an answer or of a motion for summary judgment."
