The Elections Division (the "Division") files this Motion to Set Hearing pursuant to the Hearing Officer's Amended Order dated July 18, 2024. The parties conferred by telephone on this matter on July 23, 2024.

The Division filed, and Unite for Colorado ("Unite") did not oppose, a Motion to Stay proceedings in this matter on July 22, 2024. The parties agree that this matter should be stayed, and therefore that no deadlines should be set, until a final judgment has issued in the related case of *Colorado Department of State v. Unite for Colorado* ("Unite I"), currently pending a decision on Unite's Petition for Certiorari to the Colorado Supreme Court (Case No. 2024SC281).

Pursuant to the Hearing Officer's July 18 Order, however, and in the event that the Division's Unopposed Motion to Stay is not granted, the Division proposes, and Unite does not oppose, the following schedule:

- Discovery deadline: October 30, 2024
- <u>Deadlines for Dispositive Motions</u>
  - o Motions: November 29, 2024
  - o Responses: December 20, 2024
  - o Replies: January 3, 2024
- Deadline for filing prehearing statements, exhibits, and witness lists: January 10, 2024
- Hearing: January 16 and January 17, 2024

For the foregoing reasons, as well as those set forth in the Division's Unopposed Motion to Stay, the Division respectfully requests that proceedings in this matter be stayed until all appeals for *Unite I* have concluded.
