### **ORDER**

---

1. Petitioner has filed a disciplinary action against Respondent's notary commission alleging five violations of the Revised Uniform Law on Notarial Acts, § 24-21-502, et seq., C.R.S.


- a. Notarizing a document in which the notary has a disqualifying interest, in violation of § 24-21-504(2);
- b. Failure to adhere to personal appearance requirements for notarization, in violation of § 24-21-506;
- c. Improper or missing notarial certificate, in violation of § 24-21-515(1);
- d. Failure to Maintain a journal and Inaccurate Entries, in violation of § 24-21-519, and;
- e. Unauthorized practice of law, in violation of § 24-21-525(1)(a).

2. Counsel for the Division has filed an unopposed Motion to Stay Proceedings in that the Division and Respondent “have agreed to the general terms of a settlement” of the case. Motion, ¶ 2.


3. The stay is GRANTED. However, the Division “shall file a motion of dismissal with the hearing officer...[or] move the hearing officer to lift the stay and resume proceedings” on or before May 5, 2025—which is the date set for the hearing by the March 27, 2025 Scheduling Order. Rule 3.9.2 of General Policies and Administration, 8 CCR 1503.


