Pursuant to § 1-45-111.7, C.R.S. (2024), the Elections Division of the Secretary of State files this complaint against the Committee to Elect Jim Chamberlain Huerfano County Commissioner ("Respondent" or the "Committee").

### **BACKGROUND**

- To facilitate compliance with reporting and disclosure requirements, Colorado law prohibits candidate committees from accepting individual cash contributions that exceed \$100.
- 2. Here, the Committee accepted a \$600 cash contribution in September 2024. And although the Committee later returned that contribution, it did not do so until March 28, 2025, nearly five months after the 2024 election.
  - 3. Accordingly, the Elections Division brings this action for appropriate relief.

### **PARTIES**

- 4. Complainant is the Elections Division ("Division") of the Colorado Secretary of State.
- 5. Respondent is the Committee to Elect Jim Chamberlain Huerfano County Commissioner, a candidate committee registered with the Colorado Secretary of State, ID # 20245047130.

### **JURISDICTION AND VENUE**

- 6. The Division has jurisdiction under § 1-45-111.7.
- 7. The Division files this complaint with a hearing officer consistent with § 1-45-111.7(5)(a)(IV).
- 8. This complaint is timely filed within thirty days of the Division's May 15, 2025, Notice of Investigation, according to § 1-45-111.7(5)(a)(IV).
  - 9. Venue is proper before the hearing officer under § 1-45-111.7(5).

### **ALLEGATIONS**

- 10. In 2024, Jim Chamberlain ran for County Commissioner in Huerfano County. The candidate committee formed to support his candidacy was the Committee to Elect Jim Chamberlain Huerfano County Commissioner.
- 11. On September 27, 2024, the Committee received a \$600 cash contribution. By law, that contribution exceeded the allowable cash contribution limit by \$500.
- 12. On March 5, 2025, the Division filed a complaint against the Committee under section 1-45-111.7(7). The complaint alleged that the Committee had accepted a cash contribution in excess of the allowable limit.
- 13. In response to the Division's complaint, the Committee cooperated with the Division's review and investigation, and cured the alleged violation by returning the \$600 contribution on March 28, 2025.

### COLORADO CAMPAIGN FINANCE LAW

14. Under Colorado law, candidate committees are prohibited from accepting contributions "in currency or coin" exceeding \$100. Colo. Const. art. XXVIII, § 3(10).

# CLAIM ONE ACCEPTING CASH CONTRIBUTION EXCEEDING \$100 (Colo. Const. art. XXVIII, § 3(10))

- 15. All preceding allegations are incorporated.
- 16. On September 27, 2024, the Committee accepted a cash contribution in the amount of \$600.
- 17. This was \$500 greater than the cash contribution Colorado law permits candidate committees to accept.
- 18. The Committee returned the contribution, but not until after the 2024 election. As a result, the Committee enjoyed use of the contribution during the 2024 election.
- 19. The Division is entitled to relief under Article XXVIII of the Colorado Constitution and the Fair Campaign Practices Act, § 1-45-101 et seq.

### PRAYER FOR RELIEF

WHEREFORE, the Elections Division prays for judgment and relief as follows:

- 1. Penalties as set out under 8 CCR 1505-6, Rule 23.4.3.
- 2. Such other relief as the Hearing Officer may deem appropriate.
