### **SCHEDULING ORDER**

---

1. Complainant filed an Administrative Hearing Officer Complaint June 16, 2025. In three counts, the Complaint alleges violations of the Fair Campaign Practices Act (FCPA), § 1-45-101, et seq. C.R.S., in the 2024 election cycle.

2. The pleadings, actions and events in this case shall happen on the schedule below. Where a date is on the weekend or a holiday, the date is extended to the next business day. All pleadings shall be served on the hearing officer at [administrativehearingofficer@coloradosos.gov](mailto:administrativehearingofficer@coloradosos.gov) and on the other persons using the coordinates shown for them in the Certificate of Service below.

3. **Dispositive motions**, if any, shall be filed on the date that pre-hearing statements are due, with responses and replies due 14 and 21 days thereafter. The filing of a dispositive motion by one party relieves both parties of the obligation of filing a prehearing statement at the time set forth above. After a ruling on dispositive motions, an amended scheduling order will issue that establishes new dates for pre-hearing statements, exchange of exhibits and the hearing.

4. Motions shall be handled in accordance with Campaign & Political Finance [CPF] Rule 24.9, 8 Code Colo. Regs. 1505-6.

5. **Prehearing Statements** shall comply with CPF Rule 24.11.

6. **Exchange of exhibits.** Exhibits of the parties are to be exchanged on the same date that Prehearing Statements are filed.

7. **Exhibit format.** Exhibits of the parties are to be filed on the same date as the Prehearing Statements. Each party shall put its exhibits in a single bookmarked pdf file, with each exhibit labeled (with the Division using numbers and the Respondent using letters) and bookmarked within the pdf file. The exhibit “labels” must contain the exhibit number or letter, the hearing date and the case number.


8. **Trial Efficiencies.** Include an estimate of time needed for direct examination of each witness in each parties’ case in chief, as well as the amount of time required to try the case.

9. The Division shall file **a single exhibit list**, noting stipulations as to admissibility and objections by the parties, using the template that will be provided by the Court Clerk on request.

10. **Hearing in this matter**, pursuant to §1-45-111.7(6)(a) and §24-4-105, C.R.S. is hereby scheduled for Tuesday, August 19, 2025 at 2:00 PM in the hearing room of the Secretary of State at 1700 Broadway, Suite 550, Denver, Co 80290.


