(Be it enacted by the People of the State of Colorado) that SECTION 17 Article 1
of title 22, Colorado Revised Statutes, is amended BY THE ADDITION OF A
NEW SECTION to read: public schools in the State of Colorado will provide a five
minute period of time at the beginning of each school day which shall be called
"Private Meditation" during which the student can invoke private or group prayer
or have personal meditation and reflection time. A student that does not wish to
utilize this time may remain quiet or utilize the time for curricular purposes.
