Be it Enacted by the People of the State of Colorado:

Section 42-4-1503 (2) and (3), Colorado Revised Statutes, is amended, and the said 42-4-1503 is further amended by the addition of a new subsection:

42-4-1503. Operating motorcycles on roadways laned for traffic.

- (2) The operator of a motorcycle shall not overtake or pass in the same lane occupied by the vehicle being overtaken except as provided by subsection (7) of this section.
- (3) No person shall operate a motorcycle between lanes of traffic or between adjacent lines or rows of vehicles except as provided by subsection (7) of this section.
- (7) THE OPERATOR OF A MOTORCYCLE MAY OPERATE THE MOTORCYCLE BETWEEN LANES OF TRAFFIC MOVING IN THE SAME DIRECTION DURING PERIODS OF TRAFFIC CONGESTION IF THE OPERATOR:
 - (a) IS AT LEAST EIGHTEEN YEARS OLD;
 - (b) HAS SUCCESSFULLY COMPLETED A STATE APPROVED MOTORCYCLE OPERATOR TRAINING AND SAFETY COURSE;
 - (c) OPERATES THE MOTORCYCLE:
 - (I) AT A SPEED NOT MORE THAN TEN MILES PER HOUR OVER THE SPEED OF THE OTHER TRAFFIC;
 - (II) IN TRAFFIC THAT IS MOVING AT LESS THAN ONE HALF THE POSTED SPEED LIMIT;
 - (III) IN A LOCATION OTHER THAN A SCHOOL CROSSING ZONE OR OTHER THAN A LOCATION WHERE THE POSTED SPEED LIMIT IS 20 MILES PER HOUR OR LESS;
 - (d) DISPLAYS AN INDICATOR OF COMPLIANCE, IN THE FORM OF A STICKER OR SPECIAL LICENSE PLATE TO BE PROVIDED BY THE DEPARTMENT OF REVENUE UPON BEING PROVIDED PROOF OF COMPLIANCE BY THE OPERATOR.
