MOTION FOR REHEARING ON INITIATIVE 2013-2014 #41

Don Macalady, through legal counsel, Recht Kornfeld P.C., objects to the Title Board's title and ballot title and submission clause set for Initiative 2013-14 #41.

On April 2, 2014, the Board set the following ballot title and submission clause:

Shall there be a change to the Colorado Revised Statutes repealing prohibitions against the sale, transfer, or possession of large-capacity ammunition magazines enacted by the general assembly in 2013?

ADVISORY GROUNDS FOR RECONSIDERATION

The title is misleading and confusing, in violation of C.R.S. 1-40-106, -107 for the following reasons:

- 1. The title's reference to "a change to the Colorado Revised Statutes" is an uninformative, and indirect way of stating what this proposal actually does, which is to repeal a statutory restriction on large-capacity magazines.
- The title fails to state that the statute referred to also authorizes the possession of largecapacity magazines under certain situations, making the sole reference to "prohibitions" inaccurate.
- 3. The title fails to state that there is a specific definition of "large-capacity magazine" that is contained in the statute being repealed.
- 4. The title fails to state that the proposed measure repeals the requirement for mandated stamps or identification markings for large-capacity magazines that are manufactured or assembled in Colorado after July 1, 2013

- 5. The title fails to state that the proposed measure prohibits the manufacture of unstamped large-capacity magazines.
- 6. The reference to a statute that was "enacted by the general assembly in 2013" is unnecessary verbiage, as: (a) the title already refers to a statutory repeal and no measure may become a statute without being enacted by the General Assembly; and (b) a statute is not actually "enacted" unless it is also signed by the governor or allowed to become law by passage of the ten-day period for signing.

An accurate ballot title and submission clause would read:

Shall there be a repeal of the Colorado Revised Statute that: prohibits sale, possession, or transfer of certain large-capacity ammunition magazines; authorizes sales, possession, or transfer of such magazines under specified circumstances; defines "large-capacity magazine;" and prohibits manufacture of such magazines in the state that do not bear the required stamp required after July 1, 2013?
