Ballot Initiative 2017-2018 Summary

The single subject of the proposed initiative is to improve the implementation of SB251 by allowing the social security card and/or an ITIN number in any Department of Revenue offices in Colorado that issues documents. Currently, a person who is not lawfully present in the United States may obtain an identification card, an instruction permit or a driver's license if certain requirements are met. One of the requirements is that the applicant presents a taxpayer identification card. The ballot initiative allows a social security number to meet this requirement, as well as to allow the license or identification card to be reissued or renewed in accordance with the process used other licenses and identification cards, the department shall issue an identification document to any applicant in any office through which the department issued driver's licenses, permits, identification, and there shall not be any limits to the number of identification documents issued.

- (b) (I) Any license referred to in section 42-2-114 OR 42-2-505 that, at the time of its expiration, is held by a resident of this state who is temporarily outside of this state or is prevented by disability from complying with paragraph (a) of this subsection (1) SUBSECTION (1)(a) OF THIS SECTION may be extended for a period of one year if the licensee applies to the department for an extension of the expiration date prior to BEFORE the date the license expires and pays a fee set by the department in accordance with section 42-2-114.5 (2).
