The single subject of the proposed initiative is to improve the implementation of SB251 by allowing the social security card and/or an ITIN number in any Department of Revenue offices in Colorado that issues documents. Currently, a person who is not lawfully present in the United States may obtain an identification card, an instruction permit or a driver's license if certain requirements are met. One of the requirements is that the applicant presents a taxpayer identification card. The ballot initiative allows a social security number to meet this requirement, as well as to allow the license or identification card to be reissued or renewed in accordance with the process used other licenses and identification cards, the department shall issue an identification document to any applicant in any office through which the department issued driver's licenses, permits, identification, and there shall not be any limits to the number of identification documents issued.

- 2 SECTION 1. In Colorado Revised Statutes, 42-2-505; amend (1)

Renewal - duplicate - replacement - rule. 10 (1) Renewal. An identification document issued under this part 5 expires 11 three years after issuance. The holder of the document must apply for 12 renewal in ACCORDANCE WITH SECTION 42-2-118 OR 42-2-304 to continue 13 to hold a valid identification document. TO RENEW THE IDENTIFICATION 14 DOCUMENT ISSUED TO A PERSON WHO IS NOT LAWFULLY PRESENT, THE 15 HOLDER MUST PRESENT THE IDENTIFICATION DOCUMENT AND PROVIDE 16 EVIDENCE OF CURRENT COLORADO RESIDENCY AS DETERMINED BY THE 17 18 DEPARTMENT BY RULE. (2) Duplicate permits and minor licenses - replacement 19 licenses. IF AN IDENTIFICATION DOCUMENT ISSUED UNDER THIS PART 5 IS 20 21 LOST, STOLEN, OR DESTROYED, THE PERSON TO WHOM IT WAS ISSUED MAY OBTAIN A DUPLICATE OR REPLACEMENT IN ACCORDANCE WITH SECTION 22 23 42-2-117 OR 42-2-305.

19	of the required fee; passing of an eye test; passing of such other
