## Ballot Initiative 2017-2018 Summary

**Colorado Secretary of State** 

The single subject of the proposed initiative is to improve the implementation of SB251 by allowing the social security card and/or an ITIN number in any "Department of Motor Vehicles" which the department issues documents. Currently, a person who is not lawfully present in the United States may obtain an identification card, an instruction permit or a driver's license if certain requirements are met. One of the requirements is that the applicant presents a taxpayer identification card. The ballot initiative allows a social security number to meet this requirement, as well as to allow the license or identification card to be reissued or renewed in accordance with the process used other licenses and identification cards, the department shall issue an identification document to any applicant in any office through which the department issued driver's licenses, permits, identification, and there shall not be any limits to the number of identification documents issued.

1 Be it Enacted by the People of the State of Colorado. 2 SECTION 1. In Colorado Revised Statutes, 42-2-505, amend (1) 3 introductory portion and (1)(c) and add (4) and (5) as follows: 4 42-2-505. Identification documents - individuals not lawfully 5 present. (1) Documents issued. An individual who is not lawfully present IN THE UNITED STATES may apply for an identification document 6 in accordance with this part 5. The department shall issue an 7 8 identification document to an applicant who: 9 (c) (I) Documents an individual taxpayer identification number 10 issued by the United States internal revenue service; and OR (II) DOCUMENTS A SOCIAL SECURITY NUMBER ISSUED BY THE 11 UNITED STATES SOCIAL SECURITY ADMINISTRATION, WHICH 12 DOCUMENTATION MAY INCLUDE A SOCIAL SECURITY CARD OR ANY OTHER 13 DOCUMENTATION ACCEPTABLE TO THE DEPARTMENT AS PROVIDED BY 14 RULE IF THE FEDERAL GOVERNMENT CONFIRMS THE INDIVIDUAL'S SOCIAL 15 SECURITY NUMBER, INCLUDING ELECTRONIC CONFIRMATION THROUGH THE 16

3	(III) THE DEPARTMENT SHALL ISSUE AN IDENTIFICATION DOCUMENT TO AN

(1.5) Upon furnishing satisfactory proof to the department that 5 a driver's license issued under the provisions of this article ARTICLE 2 has 6 been lost, stolen, or destroyed, the person to whom the same IT was issued 7 shall MAY apply for renewal of the license pursuant to section 42-2-118. 8 The new driver's license shall expire EXPIRES as provided in section 42-2-114 OR 42-2-509 (1). 9 10 SECTION 4. In Colorado Revised Statutes, 42-2-118, amend (1)(a)(I), (1)(b)(I), (1.3)(a) introductory portion, (1.3)(a)(II), (1.5)(a) 11 12 introductory portion, and (1.5)(a)(II) as follows: 42-2-118. Renewal of license in person or by mail - donations 13 14 to Emily Maureen Ellen Keyes organ and tissue donation awareness 15 fund - repeal. (1) (a) (I) Every license issued under section 42-2-114 shall be OR 42-2-505 IS renewable prior to its expiration, upon application 16 17 in person, by mail as provided in subsection (1.3) of this section, or by electronic means as provided in subsection (1.5) of this section; payment 18 19 of the required fee; passing of an eye test; passing of such other examinations as the applicant's physical limitations or driver's record 20 21 indicates to be desirable; and payment of any penalty, assessment, fine, 22 cost, or forfeiture as prescribed by subsection (3) of this section. If a 23 person renews his or her license pursuant to this subparagraph (I) 24 SUBSECTION (1)(a)(I) by electronic means, the person shall MUST attest

under penalty of perjury that he or she has had an eye examination by any

- (b) (I) Any license referred to in section 42-2-114 OR 42-2-505 that, at the time of its expiration, is held by a resident of this state who is temporarily outside of this state or is prevented by disability from complying with paragraph (a) of this subsection (1) SUBSECTION (1)(a) OF THIS SECTION may be extended for a period of one year if the licensee applies to the department for an extension of the expiration date prior to BEFORE the date the license expires and pays a fee set by the department in accordance with section 42-2-114.5 (2). The department shall transfer the fee to the state treasurer, who shall credit it to the licensing services cash fund created in section 42-2-114.5 (1). This AN extension UNDER THIS SUBSECTION (1)(b)(I) becomes null and void ninety days after the licensee renews his or her residency in the state or otherwise becomes able to comply with the provisions of paragraph (a) of this subsection (1) SUBSECTION (1)(a) OF THIS SECTION.
