SECTION 1. In Colorado Revised Statutes, **add** part 2 to article 21 of title 35 as follows:

PREVENT CRUELTY TO FARM ANIMALS

THE PURPOSE OF THIS ~~ACT PART 2~~ IS TO PREVENT ANIMAL CRUELTY BY PHASING OUT EXTREME METHODS OF FARM ANIMAL CONFINEMENT. ~~EXTREME METHODS, WHICH ALSO~~ THREATEN THE HEALTH AND SAFETY OF COLORADO CONSUMERS; AND INCREASE THE RISK OF FOOD-BORNE ILLNESS AND ASSOCIATED NEGATIVE FISCAL IMPACTS ON THE STATE OF COLORADO.
