You can ignore references to any ClearVote products that are not part of your voting system. Also ignore implementation options that are not relevant to your policies and procedures.

Chapter 1. Verifying the ClearAccess software

After installing your ClearAccess software, you need to verify that the SHA-256 hash values of the installed software match those of the certified version. This process ensures that a third party or malware has not changed the contents of the software.

1.1 Steps to verify the software

To verify the installed software:

- 1. At the ClearAccess station, log in to Windows as the ClearAccess user.
 - The ClearAccess program starts and displays the login screen.
- 2. Log in with the administrator role and password.
- 3. Insert a USB drive into one of the available USB ports on the ClearAccess station.
- 4. Click About.

ClearAccess displays the About page.

5. Click the **Clear Ballot Product Files** tab and then click the **Export** button.

A message indicates that ClearAccess saved the product information as a CSV file on the USB drive

- 6. Click **OK** to close to close the message.
- 7. Close the About page and log out of the ClearAccess station.
- 8. Remove the USB drive from the ClearAccess station and insert it into another computer running Microsoft Windows.
 - Another computer is necessary because ClearAccess hardening prevents opening and viewing the file on the ClearAccess station.
- 9. Use a text or spreadsheet program, such as Notepad or Excel, to open and view the exported file.
- 10. Compare the hash values in the exported file to the hash values in Table 1-1 on page 7.
 - If the hash values match, the software is unmodified and matches the certified version.
 - If the hash values do not match, the software on the station does not match the certified version. The software has been modified, was improperly installed, or does not match for some other reason.
- 11. If a mismatch is found, do one of the following:
 - Follow procedures of your jurisdiction to resolve the discrepancy.
