Colorado Palestine Club and its director's violations of § 24-6-303, C.R.S. (3.5),(3.6),(6), § 24-6-308,C.R.S. (c),(f),(h),(i) and (n) as well as C.R.S. Title 1-45-103.7 (5)(b)(III), (5.5)

The members and directors of the Colorado Palestine Club (a.k.a. Colorado Palestine Coalition), Reema Wadhan and Abdullah Elagha are operating as professional lobbyists, operating a lobbying firm without registration in violation of § 24-6-303, C.R.S. (3.5),(3.6), and (6). Additionally, due to details of their associations, this appears to have been done with intent to conceal the identity for their principals and donors, the terrorist group Hamas, the Jordanian Royal Family, the Egyptian government, or the government of Qatar and for reps Tim Hernandez, Elizabeth Epps and Iman Jodeh for whom they have campaigned as well as engaged in threats against their political opponents. This would mean they are also in violation of § 24-6-308,C.R.S. (c),(f),(h),(l) and (n). Colorado Palestine Club is not a registered entity nor has it registered as a lobbyist entity, nor have Mrs. Wadhan or Mr. Elagha. Mr. Elagha is of particular concern as he appears to have family ties to the terrorist group Hamas.

The failure to register is because under C.R.S. Title 1-45-103.7 (5)(b)(III), (5.5), -107.5 (1) foreign governments may not register as a PAC or make contributions which the Colorado Palestine club has made. In reference to their engagement with rep Tim Herandez and Iman Jodeh this appears to also be a possible violation they engaged in with full knowledge of its criminality.

Violation of § 24-6-303, C.R.S. (3.5),(3.6), and (6), failing to register as a lobbying firm:

The following incidents represent unregistered professional lobbying of Colorado elected officials engaged in by Mrs. Wadhan and Mr. Elagha under the name of the Colorado Palestine Club in activities that would require them to register as professional lobbyists under § 24-6-303, C.R.S. (3.5)(a)(I)(A),(3.6), and (6):

- On February 26th 2024, at 7:28:37 PM, Mrs. Wadhan appeared before the House Committee on finance to discuss support for HB24-1169, which was a bill exclusively sponsored and supported by Elizabeth Epps. Epps has received support from the Colorado Palestine Club. HB24-1169 was a bill to repeal the prohibition against forced divestment of CO PERA funds from Israeli investments and companies. It should be noted that the principal benefactors of this proposed legislation are Hamas and Iran, who have been seeking to reduce Israel's defensive capabilities. This would indicate the principals on whose behalf Colorado Palestine Club is engaged in professional lobbying to benefit.
- At some point between May 15th 2021 and February 13 2023, Mr. Elagha and Terry Burnsed claimed to Cassis Tingley of the DU Clarion that they engaged in "direct political action to pressure Colorado representatives to end the training exchange program between Colorado law enforcement and Israeli military forces, coined "the deadly exchange" by Jewish Voice for Peace and which Burnsed called "a birthright trip for cops." This appears to have been targeted at ending the policy which allows for Denver police to be trained in anti-terror enforcement in Israel based on links in the articles to their proposals which were subsequently deleted. This activity appears to

have been sponsored by a group out of NY calling themselves "Researching the American-Israeli Alliance" (RAIA).³ This appears to be an LLC located in NY. It is unclear if the entity is registered there, but the website appears to be defunct and their social media has been derelict since 2022. This DU Clarion article also references other unregistered lobbying activities that may need to be refereed to a different agency.

From March 2024 through May 2024, Colorado Palestine Club staged protests at the University of Colorado Anschutz campus and other university campuses in Colorado. These protests made various demands of the regents to establish policies, such as divesting from all investments in companies that do business in Israel in any way, stopping collaborative research efforts with Israel, bringing in Palestinian staff and students through the "welcome corps" program sponsorships and creating Islamic Centers on campus. The activities include appearances at a regent's personal residence to stage protests at 3372 Huron Peak Ave, Superior CO 80027 on June 1st 2024.4



 On November 28th 2023, at 9:46am after disrupting a session of the state house with "from the river to the sea" chants, Mr. Elagha met with Iman Jodeh, Jen Bacon, Javier Madrey and Tim Hernandez privately to discuss policy, as reported by The Denver Post.⁵ Posts made to Twitter on the Colorado Palestine Club account show that they

Payment for political activities establishing requirement to register for professional lobbyist status under § 24-6-303, C.R.S.

The following post appears to have been made by Mrs. Wahdan to Reddit, under the account "letmeflyfish", regarding the Auraria Campus protests, on May 3rd 2024, indicating she was the principal organizer. Via Venmo, she received at least 3 payments related to this specific activity in unknown amounts from Bassel Whadan, Khadija Senesac and Ahmad Rashi. Payments to Mrs. Wahdan appear to have begun on September 11th 2020.8

Other posts indicate that they are receiving micro donations online as payment for their activities in various campaigns, using other groups for the receipt, including an ongoing campaign with Democratic Socialists of America.9 Democratic Socialists of America contributions to the CO Palestine Club on donorbox.com are set to be taken in foreign currency. The donations that were taken in foreign currency will appear repeatedly with amounts that were suggested by the group when setting up a donorbox.com page to take donations in one of 45 different currencies that donorbox.com accepts, including Egyptian Pounds. The user can set differing amounts in each of the currencies as suggested donations, which will then appear as repeating transactions in the donor register¹⁰. From the analyzed transaction log supplementing this complaint \$9768.24 of the \$11,904.37 received is from foreign sources during the course of the various campus protests from March 2024 to May 2024. It should be noted that the divestment demands were being made of the regents specifically and that regents of Denver Metro University and the University of Colorado are also Colorado state elected officials, making this additional paid lobbying activity. This "lobbying activity" includes appearances at the regent's personal residence to stage protests at 3372 Huron Peak Ave, Superior CO 80027 on June 1st 2024. This would indicate that this is also being used as a means of giving foreign funds to various political candidates while obscuring the source of the transactions. This would appear to be in violation of § 24-6-308, C.R.S. (c) and (h).

Additionally, the directors of Colorado Palestine Club have made it clear that they are soliciting corporate sponsorships¹¹. One of these sponsors is documented in media as engaging with these groups as a fiscal sponsor, "Students for Justice in Palestine which, according to the Colorado Palestine Club, operates under their umbrella. National SJP is legally a "fiscal sponsorship" of another nonprofit: a White Plains, New York, 501(c)(3) called the WESPAC Foundation. A fiscal sponsorship is a legal arrangement in which one nonprofit organization "sponsors" another organization, essentially lending the other organization the sponsor's tax-exempt status and providing back-office support, thereby obscuring the source of funds used by the other organization. For legal and tax purposes, the sponsor and the beneficiary of the sponsorship are the same entity, meaning that the beneficiary of the sponsorship may be relieved of the requirement to independently disclose its donors or file a Form 990 with the IRS."12 As Colorado Palestine Club is an unregistered entity, that would mean that they also might be considered to legally be a part of any entity that acts as a fiscal sponsor, this includes a large number of organizations that Colorado Palestine Club claims operate under their banner. According to the current website of the Colorado Palestine Club they have formed a coalition group which consists of Colorado Palestine Club, Democratic Socialists of America, Jewish Voice for Peace, Friends of Sabeel, Students for Justice in Palestine, Party for socialism and Liberation, Students for a Democratic Society, Palestinian

Youth Movement, Freedom Road Socialist Organization, Colorado Center fro Freedom & Justice, Shades of Honey, Colorado May Day Club, Colorado Joint MSA and the Shoes-Off Collaborative.¹³

Some of these groups, specifically Shoes-Off Collaborative and Jewish Voice for Peace¹⁴ also have activities with a not for profit Reema is a co-president of, called the Al Bireh Society¹⁵, that involves training people to lobby for Palestinian interests. Reema might be using Al Bireh as a fiscal sponsor as well, the Al Bireh Society INC, located out of Tampa, FL.¹⁶ This Tampa address 1806 N Franklin St resolves to Giant Oil Inc¹⁷, which is run by owner Basem Ali. whose name does not appear on the Al Bireh Society INC 990 fillings. The board members include directors who are otherwise employed by the Jordanian Government, indicating funding from Qatar and the Jordanian royal family and government may be co-mingled with the Colorado Palestine Club resources. 18 Hamas' stated goal, per their charter, is to enact a genocide against Jews, as stated in the Hamas covenant of 1988 article 7¹⁹. Hamas does pay Palestinians specifically for killing Jews under their slay for pay program.²⁰ It is highly likely that Abdullah, Reema and Iman Jodeh are all receiving some form of payment from Hamas itself, for their political activities including lobbying done by the Colorado Palestine Club. Often these types of payments are received by family members instead of directly. For instance, monthly stipends of tens of thousands of dollars for engaging in a terrorist attacks paid to surviving family members of martyrs or 50 lbs of flour per month paid to Gaza residents for each child that attends an UNRWA school).


Fundraising activity and illegal campaign contributions made by foreign persons in violation of § 24-6-308,C.R.S. (c),(f),(h),(l) and (n).

• The Colorado Palestine Club has hosted multiple other events for Tim Hernandez including a fundraiser on Oct 7th 2023,²¹ where Hernandez made comments about Israel that he took back days later²². This makes it clear that he is being influenced by these illegal foreign campaign contributions. He has also afterward made several statements in support of Colorado Palestine Clubs activities to push every city council statewide to make a declaration demanding Israel stop it's war before eliminating the terrorist group Hamas which invaded Israel and killed 1,200 Israelis on Oct 7th 2023²³, in addition to taking approximately 250 Israelis as hostages.

 The Colorado Palestine Club hosted a fundraiser for Tim Hernandez on June 9th 2024, at 5709 E Colfax Ave, Denver CO 80220.²⁴ This included the Colorado Palestine Club personally collecting donations for his re-election campaign in HD4. This is also a violation of campaign finance statutes, since Colorado Palestine Club is acting as PAC without proper registration, in addition to making donations raised from foreign sources.



Additionally, there appears to be a relationship between representatives Elizabeth Epps, lman Jodeh and the directors of the Colorado Palestine Club, which shows possible campaign support and organization that was not properly disclosed, which could be considered a provision

of services for election support in violation of \S 24-6-308, C.R.S. (c), (f), (h) and/or (l) and may or may not include fund-raising activities.


- On May 14th 2021, at 4PM, the Colorado Palestine Club held a rally at which Hon Joe Salazar, state senator Julie Gonzales and rep Iman Jodeh were speakers, alongside representatives from the Colorado Palestine Club. One of the goals of the rally was to elicit support for H.R 2590 in Congress.²⁵ This bill also appears to be a bill in the interest exclusively of Hamas and Iran to the detriment of Israel and Israeli-American relations, which may implicate the stated elected officials as the principals facilitating the activities of this group.
- Iman Jodeh has spoken at events organized by the Colorado Palestine Club, including on May 4th 2023,²⁶ which events appear to be with groups of other Palestinian individuals, making this a rally to introduce her to voters and donors favorable to a pro-Hamas candidate.

Iman Jodeh has made public social media posts on Instagram showing she has a
personal relationship with Mrs. Wahdan that may include other unknown lobbying
incidents.²⁷



• The Colorado Palestine Club social media accounts were also promoting rep Elizabeth Epps and her federal and food nutrition programs. This is a possible exchange of benefits provided by the organization to Epps, as the Colorado Palestine Club has no other interest in this topic whatsoever, as indicated by their social media.²⁸ Within a week after receiving that support, rep Elizabeth Epps came out with a statement of support for the Colorado Palestine Clubs' campus protest activities indicating her attendance.²⁹ There appears to be a pay for play relationship between rep Elizabeth Epps and the Colorado Palestine Club that may include a similar relationship to their relationship with reps Tim Hernandez.

 As stated above, on November 28th 2023, at 9:46am after disrupting a session of the state house with "from the river to the sea" chants, Mr. Elagha met with Iman Jodeh, Jen Bacon, Javier Mabrey, Tim Hernandez and Sen. Nick Hinrichsen privately met to discuss policy as reported by The Denver Post.³⁰ Posts made to Twitter on the Colorado Palestine Club account show that they organized the protest and that he was present.³¹

The following incidents indicate attempts to influence public officials with threats in potential violation of § 24-6-308, C.R.S. (h).

- Targeted harassment of Rep Diana DeGette on June 29th 2021, posted by members of the Colorado Palestine Club to Tiktok account.³²
- Calls to target harassment against Jared Polis on November 29th 2023, posted by the Colorado Palestine Club to their Tiktok account,³³ including protests against Jared Polis at the JNF conference showing that they are using protests as an active tool of intimidation against Jewish lawmakers in the interest of obtaining a policy goal.³⁴

Additional potentially relevant information and terrorist associations.

Although it is not a part of the above state statute violations, I want to make it clear that multiple parties above have terrorist group associations or have some administrative responsibility over Colorado individuals currently calling for killing Jews in Colorado by way of martyrdom.

• Mr. Elagha has made it clear multiple times that he has family that was arrested for participation in Oct 7th attacks in Israel, which family members left to kill Jews after the initial attacks were reported in American media. This has been both in his personal social media posts³⁵ and in reporting on the activities of the Colorado Palestine Club³⁶. He has a history of pro-Hamas, anti-semitic political activity that he has periodically documented online.³⁷ He regularly organizes meetings at 2300 S Parker Rd at the Saj Fresh Mediterranean Grill³⁸. This is near a Islamic Center associated with Iman Jodeh known to promote terrorism including martyrdom. Due to the relationships between parties and the proximity it is highly likely that the individuals who attend are also being indoctrinated with terrorist ideals.

- Rep Iman Jodeh represents Imam Karim Abu Zaid as their public relations director and general secretary.³⁹ This mosque is located at 2071 S Parker Rd, Denver, CO 80231. Imam Karim Abu Zaid has been recorded in multiple instances demanding Jews be expelled from Israel⁴⁰ and calling for Jews in the US to be killed by way of his congregants martyring themselves⁴¹ as well as indoctrinating small children with this murderous rhetoric⁴². This is in line with the Hadith and Tassir interpretations that the Hamas covenant of 1988 article 7 is based on from sharia law⁴³.
- Mrs. Wahdan is a doctor that is an employee of CU Anschutz medical school. It is unclear if she has patients but she may pose a danger to them, especially Jewish patients, as she has made it clear she poses a danger to students.⁴⁴ It is also unclear if she has already acted in line with her ideals within her career and used medical access to patients to kill Jews.
- Due to their foreign and domestic government ties these individuals may represent a significant flight risk.
