Notice of Hearing on the Closure of Inactive Committees

Date of Notice: August 14, 2012

Date of Hearing: August 31, 2012 from 10:00 a.m. to 12:00 p.m.

I. Notice and purpose of hearing

The Secretary of State gives notice as follows for a public hearing concerning the closure of inactive committees. A hearing is scheduled for **August 31, 2012 from 10:00 a.m. to 12:00 p.m.** in the Blue Spruce Conference Room on the second floor of the Secretary of State's Office at 1700 Broadway, Denver, Colorado 80290.

At the hearing, the Secretary of State will determine whether the committees listed below are inactive and closed. In accordance with Election Rule 12.5 and section 24-4-105, C.R.S., after receiving evidence and testimony, the Secretary of State will determine whether to terminate a committee.

II. Authority and requirements

In accordance with Campaign and Political Finance Rule 12.5, a committee is inactive if it fails to file any reports with the appropriate filing officer for six consecutive reporting periods or 18 months, whichever is shorter. Additionally, the Secretary of State may close an inactive committee after six missed reports or 18 months of non-reporting, whichever happens first." (See also: *Article XXVIII, section 2(3) of the Colorado Constitution and section 24-4-105, C.R.S.*)
