Thank you for the opportunity to provide written comment regarding the potential draft rules relating to Election Rule 43 and the proposed revised Conditions for Use for the Hart Voting System. After reviewing the documentation provided, Hart offers two items in the Use Conditions for consideration.

- Hart believes the reference to "the Tally database" in Software Condition 1.b should be changed to "the BOSS database." Memory cards, also referred to as Mobile Ballot Box cards or MBBs, are created in the Ballot Origination Software System (BOSS) application. Once all cards are created the BOSS database is "finalized" and subsequently used by the Tally application to create the official tabulation and accumulation database on Election Day. It would follow that archiving and securing the finalized BOSS database on closed CD Media in the manner described would be the proper best practice.
- 2. The reference to "M650" under Central Count Scanner Conditions is not a Hart Voting System application or device. Ballot Now is the Hart Voting System application used to process paper ballots in a central count environment.
