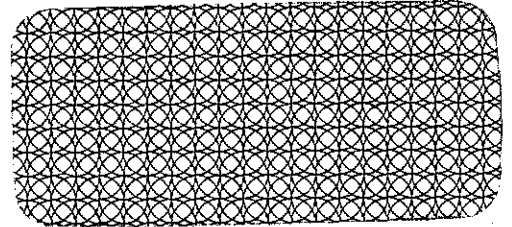

Michael says:

When it comes to Sprint's inserters the Envelopes we currently use are the largest size the runs through the majority of my inserting equipment. I do have one jumbo sized inserter that can go larger but I need more than one inserter running to meet our tight deadlines. My thoughts are that we are going to have to fit that sentence in somewhere on the current sized Return Envelope. I know with Rio Grande it becomes problematic because it has to be on there twice. Hope it does not pass.

I did point out to Michael there are two rules, so it will be more than one sentence 😊😞.

Have you spoken with any of the counties who use Response Technology? Might not hurt to see how they propose to handle this. Let me know if you do and I will see if I can get any input, too.

Judd:

Is there a possibility of a waiver if we can not fit everything onto the ballot envelopes with the bilingual? We are really questioning how this is going to work anyway. How will stand alone boxes be monitored for who actually drops the ballot in the box? Even the drop off boxes in our office will be difficult to control. Are we going to have to check IDs of everyone who drops off a ballot to make sure it is theirs or someone else's? And what if the third party delivery is not completed, will we refuse the ballot or have to send them another damn letter in Spanish and English? I just can not see this as being something we can enforce. We can't get the voters to mark the boxes correctly with instructions on the ballot. Many don't even sign the envelope. Why make a rule that is not enforceable? If I see this as being this difficult in my small county, I can't imagine what the big counties will do.
