A - Mandatory attendance and testing required.

- 1) Mandatory attendance to Campaign finance classes.
 - 2) A written test that has to be passed of campaign finance procedure.
 - 3) Failure can mean forfeiture of candidate right.
- Ensure proper administration of legislation recently passed by the Colorado General Assembly;
 - Establish uniformity in the administration of current law;
 - Eliminate obsolete provisions; and
 - Simplify the language of existing rules.

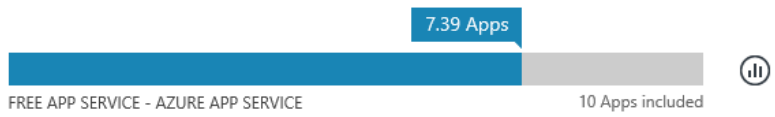


