Thank you for the opportunity to comment. Please let me know if you have any questions.

Adams County has the following questions and comments regarding the Draft Proposed Rules.

- 1. Please define "detention center". We assume that half-way houses would not be covered given they are primary used for felons who are ineligible to vote.
- 2. Given that an incarcerated person's eligibility to vote can change rapidly and, given that our CDOC notifications are not always timely, we presume that the Sheriff would assist the Clerk in determining current voter eligibility at the time ballots were delivered.
- 3. The draft says that the Clerk "must make efforts" to coordinate with the Sheriff. If the Sheriff isn't receptive, what are the Clerk's obligations?
- 4. What residential address should incarcerated eligible voter's use? May they use the facility address or should their address be the last place they resided before being incarcerated?

- Remove language that is duplicative of statute.
