Keeping track of which voters to email would be a very manual process. SCORE auto generates
correspondence however the letter does not indicate that a voter is covered. To our knowledge
a list would need to be made as data entry takes place to indicate which voters will receive
email correspondence.

- This is completely unknown based on each election. We could have a higher turnout due to participation from different entities and need addition judges.
- Does this rule include Municipal, Special District, and Special elections? Our County conducts
 Municipal and Special District elections, which sometimes can get cancelled or can be very small
 and require less judges.

- County jail flags do not reset in SCORE. It would be nice to have a specific transaction source for County Jail and not just department of corrections which implies more of CDOC cancellations.
 - This rule also suggests that the logs of ballots returned is specific to non-State elections.

7.7.8

- This rule would designate another Judge or Staffer just to manually maintain this log. Not all counties have access to a ballot sorter.
- Tier 1 and Tier 2 can be combined in small to medium counties. In our county if a single judge thinks a signature is discrepant it is escalated with 2 other judges and a decision is made at that time. This could be difficult for smaller counties that do not have multiple signature verification teams.
- SCORE reports can capture who did the reviews of the signatures, but does not capture how
 many images or which images were used to make their decision.

• Does this mean both sides of the envelope or just the side that signatures are on? Is there a waiver for counties that don't have this capability with their vendor?

- 2 rules back-to-back numbered the same. Position names and Ballot style names both 7.17.2
- Ballot Style Names (7.17.3?)
 - This is really taking the naming convention away from the County. Is there basis for this that could be handled differently? When you potentially could have 4 ballot styles in the same precinct your proposed naming convention of a number at the end of the same starting precinct number. Could be more room for error of issuing the wrong ballot style.
